Foreword

Dear colleagues,

This collection of articles by renowned Lithuanian scholars and practitioners is designated to mark the 20 year anniversary of the establishment of Lithuanian Supreme Administrative Court. The articles provide an overview and assessment of a development of Lithuanian administrative court system and administrative law, as well as insights of its intersection and interaction with the European Union law, highlight the points of interest.

Twenty years is a short period, during which, after the restoration of Lithuania's independence, foundations of administrative justice have been laid and the courts of special – administrative – jurisdiction were established. It is therefore the time when administrative courts had to define their place in the judicial system, to lay foundations of case-law in the sphere of administrative legal relations, the time to build trust in society and recognition of their activity, which is aimed at ensuring proper guarantees of the protection of individuals' rights and legitimate expectations.

It is my personal experience that this task was an intricately complex one, since during this short period of time the legislative branch, scholars and administrative judges of Lithuania not only had to create the whole legislative base regulating administrative legal relations from scratch, to apply it, interpret it and reflect on it, but in a very short period also to scrutinize and apply yet another level of legislation – the European Union law. This collection of articles therefore aims to explore the topics, relevant to the evolvement of a relationship between the Supreme Administrative Court of Lithuania and other state powers; relationship of the Supreme Administrative Court with the European Court of Justice and the European Court of Human Rights, both on an institutional level and on the effect the jurisprudences of the European Courts have on case-law of the Supreme Administrative Court; analyzes and reflects on specific areas of case-law, where the impact on the European Union law is clearly felt.

I therefore believe that this publication will not only commemorate the anniversary of the Supreme Administrative Court of Lithuania, but will also be of a great interest to all professionals dealing with the EU and administrative law, shed more light on the operation of the Supreme Administrative Court of Lithuania in general and various aspects of case-law in particular.
